Box 2240, Land O' Lakes, Florida 34639.** In the event I choose to place my deposit on my credit card, I will complete and sign a credit card authorization form and return it to BC Hunter/BC Fisherman, LLC as directed and I understand that my final payment must be made by check or money order, in US Funds.
- I freely accept all the risks associated with all aspects of this hunting and/or fishing adventure and agree that I will sign and return the Hunter Agreement and Confirmation Letter.
- I understand that Wildlife Adventures International, Inc. ("WAIL"), reserves the right, in its sole discretion, to cancel any hunt with a full refund of the monies paid to WAIL for the cancelled hunt.

- I will be required to carry proof of citizenship to travel to Canada. This proof of citizenship may be my original or certified copy of my birth certificate (with raised seal or stamp) issued by the County in which I was born (no footprint certificates), plus a photo ID (Government or State issued) or a passport.
