BC Hunter/BC Fisherman reserves the right to make changes and/or substitutions to any itinerary. Payments are accepted by BC Hunter/BC Fisherman only with the understanding that the participants have been made aware of, and agree to, all conditions of this contract prior to sending BC Hunter/BC Fisherman such payments.

Should you wish to change any details of your trip, we will do our best to accommodate you. However, please understand that we plan and schedule each trip well in advance of your arrival date. Add-ons for Fly Fishing Adventures such as fly-in days, river jet boat days, etc. must be made at least 90 days in advance and are subject to availability. Changes to your trip date are subject to availability. We recommend the purchase of travel insurance for this trip. **All payments are final and nonrefundable.**

Travel to Canada requires that U.S. citizens carry proof of citizenship. Your original or certified copy of your birth certificate (with raised seal or stamp) issued by the County in which you were born (no footprint certificates), plus a photo ID (Government or State issued) will be acceptable. A passport is optional. It is the sole responsibility of each participant to research and obtain any needed documentation for his/her foreign destination trip.

Each participant acknowledges and affirms that he/she freely accepts and fully assumes all risks, dangers and hazards associated with all aspects of this hunting and/or fishing adventure and shall hold harmless and indemnify BC Hunter/BC Fisherman, LLC, its directors, officers, owners, affiliates, associates and contractors from any and all liability for any property damage, personal injury, or any loss whatsoever resulting from his/her participation in this hunting and/or fishing adventure.. Each participant acknowledges that there are no representations, guarantees or warranties, whether stated or implied, given with respect to the success of his/her hunting and/or fishing adventure.
